18119. Apologies for absence through the clerk.

18120. Declarations of Interest.

Cllr Addison declared a pecuniary interest for payment of an invoice.

T Hallett declared a pecuniary interest for payment of expenses.

The Declarations of Interest register was available to sign.

18121. Minutes of the meeting held on 03.10.18

The minutes and the confidential notes of the meeting held on 03.10.18 were **resolved** as a true copy.

18122. To consider payment of the invoices contained in the Expenditure Transaction Approval List.

Cllr Addison and T Hallett left the chamber whilst their expenses were discussed and approved.

All other invoices were considered, and it was **resolved** to pay the invoices as detailed on the approval list, as amended, except for Torbay Council the invoice relating to Shoalstone management fee.

18123. To discuss and note the bank statement and financial budget comparison.

The statements and financial budget comparison report were discussed and noted. Members were advised that there were no updates on the balances on the 32-day notice account, Business Instant Access account, CCLA Deposit Fund and Cambridge and Counties account.

Members considered the budget and made changes to the draft 2019/20 budget. It was **resolved** to hold a consultation in Fore Street on Saturday 1st December between 10am and 1pm to ensure that as many residents as possible had the opportunity to comment on the budget.

Torbay Council

Members were advised that Torbay Council had agreed to apply for funding to purchase life jackets for the fisherman, but the application processed meant that there would be a shortfall due to Torbay Council only being able to apply for 75% of the value of the life jackets. Members were advised that a request from Torbay Council had been received asking Brixham Town Council to split the shortfall of £13,044 three ways which included equal third proportions also being contributed by Torbay Council and Brixham Trawler Agents.

It was **resolved** not support Torbay Council's request due to concerns being raised that this could set a precedent to allow other business industries and community groups who are also responsible for providing safety equipment to apply to the Town Council for funding to support their business needs.
